Primary Election Information

Iron County is a By-Mail County. Ballots will be mailed out to all eligible voters beginning June 7, 2022. Voters must be of legal voting age, a citizen of the United States, and a resident of the voting precinct in which they are registered. If you have re-registered by the below deadlines, we will mail you a ballot to your new address. Voters can check their registration status and view specific sample ballots online at www.vote.utah.gov, call (435) 477-8340 or email clerk.group@ironcounty.net

- If mailed, ballots must have **POSTAGE** and be **CLEARLY POSTMARKED BY JUNE 27, 2022**.
- **Ballot Drop Boxes will be available at local cities and towns and on Election Day Vote Center locations.**
