Please note this is not a Corrections Deputy position. However, we will utilize this roster to fill positions as they become available. If you are interested in pursuing a career in Corrections and would like to be considered for future openings, please apply.

**SALARY:** Entry Level/Minimum Starting Wage \$18.63/hour. P.O.S.T certified applicant salary will be based on experience and qualifications/certifications (current policy will allow for up to 4% per year, into the established pay range, for verifiable corrections deputy experience). A \$5,000.00 sign on bonus is available to those applicants who have already obtained the required Utah Certifications (a two (2) year employment commitment is required). Iron County offers a comprehensive Benefit Package: Health, Dental, Vision, LTD, Life and Retirement.

### MINIMUM REQUIREMENTS INCLUDE:

- BE AT LEAST 21 YEARS OF AGE PRIOR TO GRADUATION FROM P.O.S.T ACADEMY

- HAVE A HIGH SCHOOL DIPLOMA OR EQUIVALENT
- POSSESS A VALID UTAH DRIVER'S LICENSE IN GOOD STANDING

## **GENERAL PURPOSE**

Perform the duties associated with inmate admission and release, inmate transportation, inmate care, corrections documentation, and overall correctional facility security and operations.

## **SUPERVISION RECEIVED**

Works under the general supervision of Corrections Lieutenant and/or assigned Sergeant and/or Corporal.

## **SUPERVISION EXERCISED**

- Supervises inmates by providing close and direct observation.

On an as needed or assigned basis:

- May act as Shift Supervisor in the absence of Corrections Corporal and/or Corrections Sergeant.
- May provide supervision and/or training to new Corrections Deputies during initial job training.

## **ESSENTIAL FUNCTIONS**

### Line Staff Corrections Deputy

- Observe conduct and behavior of inmates to prevent disturbances and escapes.
- Physically search inmates and living areas for contraband.
- Conduct living area inspections for evidence of prohibited activities while observing and documenting demeanor of inmates.
- Inspect locks, windows, doors, security equipment for evidence of tampering.
- Employ defensive tactics, weapons and/or other authorized use of force measures to maintain order, control and discipline within facility.
- Screen arrestees and inmates for medical and mental health issues.
- Administer inmate alcohol and drug tests.
- Supervise inmates in transit between facilities, courts, or other destinations.
- Receive arrestees, input data into computers, serve warrants, and search arrestees and property.
- Enforce rules and regulations according to established policy.
- Instruct, correct and manage inmate behavior.
- Respond to emergency situations and use physical restraints and/or approved techniques when necessary.
- Summon medical staff and render first aid when necessary.
- Assume responsibility for inmate movement throughout facility.
- Direct inmate work requirements, cleaning of living areas and housing units.
- Supervise inmates during recreation, meals, programming, visitation, counseling and other approved activities.

- Operate control room, monitor closed circuit monitoring system, control entrances, doors, and sally ports to limit specified physical contact and other safety/security purposes.
- Maintain inventory of keys, radios, weapons and other items.
- Search items and persons entering facility.
- Restrain inmates using handcuffs, waist chains, leg irons or other approved methods.
- Answer phone calls and effectively relate approved information concerning inmates to the public and other agencies.
- Safely operate a motor vehicle to attend training and transport inmates.
- Provide security while inmates are outside of facility.
- Respond to inmate complaints and provide explanation of rules and procedures.
- Collect cash bail, bail bonds and provide written receipts.
- Release inmates by following established procedures.
- Write reports in English and with necessary details as established and required.
- Respond to public and professional inquiries with professionalism.
- Maintain safety, security, control, discipline and order within area of assignment.

#### Work Crew Corrections Deputy

- Organize work projects.
- Screen inmates for participation in work programs.
- Supervise inmate workers.
- Provide training to inmates regarding operating machinery and tools.
- Acts as liaison between various governmental agencies to ensure work projects are in compliance with laws, codes and regulations.
- Maintain inventory of all equipment, tools and vehicles assigned to work crew.
- Provide detailed, daily records of projects, hours worked, agency worked for, and funds expended.
- Maintain accounting of all funds expended.
- Maintain accurate time sheet for inmate workers.
- Make arrangements for inmate meals.
- Ensure work crew inmates receive prescribed medication as needed.
- Provide security while working in the community.
- Immediately report inmate misconduct.
- Ensure work at County Fair is prioritized during established time.
- Work as Line Staff Deputy when and as needed.

#### Transportation Corrections Deputy

- Coordinate with various courts to ensure timely inmate appearances.
- Transport inmates to and from courts, other jail, medical centers and other locations as needed.
- Send and receive court information and orders.
- Enter and update computer records to ensure accuracy of information.
- Create transportation logs, including times, destinations, and inmate names.
- Conduct thorough searches of inmates before and after transportation outside of the facility.
- Restrain inmates using approved devices and equipment.
- Operate motor vehicle for extended periods of time – as needed.
- Ability to summon medical personnel and provide first aid – sometimes in remote locations.
- Inventory inmate property and money before and after transport.
- Keep travel and fund expenditure records as required.
- Ensure vehicles are properly maintained and cleaned.
- Provide daily vehicle inspections to ensure fluid levels, tire and safety equipment are at proper levels and in working order.
- Screen, process and deliver inmate mail.

- Process, inspect, label, receipt and deliver inmate commissary.
- Work as Line Staff Deputy when and as needed.

#### Culinary Corrections Deputy

- Obtain and maintain food handlers permit.
- Prepare meals as established by Facility Dietician.
- Maintain sanitation within the kitchen and dining area.
- Supervise inmate workers.
- Physically search inmate workers to prevent trafficking in contraband.
- Supervise serving portions and preparation of inmate trays.
- Ensure all trays, utensils and equipment are sanitized after each use.
- Inventory and maintain control of established sharps and equipment.
- Provide safety instruction and training to inmates operating equipment.
- Prepare a list of items needed for purchase through approved vendors.
- Coordinate food service activities with Culinary Supervisor.
- Prepare for and comply with Utah Health Department inspections and requirements.
- Clean and organize warehouse.
- Receive and store incoming deliveries.
- Ensure all food temperatures are within established limits.
- Search containers, boxes, and pallets entering facility.
- Work as Line Staff Deputy when and as needed.

### **EDUCATION AND EXPERIENCE**

A high school diploma or equivalent is required along with graduation from Peace Officer Standards and Training (P.O.S.T.) Academy.

#### **1. Knowledge, Skills and Abilities:**

- Basic knowledge of Federal, State and Local laws and regulations related to jails and prisoner rights.
- First aid techniques and practices.
- Ability to communicate effectively in the English language, both verbally and in writing.
- Ability to establish positive, professional relationships with the public, inmates, co-workers and other agencies.
- Ability to maintain composure during stressful conditions.
- Ability to perform under stress when confronted with exigent, emergent, critical and/or dangerous situations.
- Ability to handle multiple activities simultaneously.
- Ability to exercise sound judgement under stressful circumstances.
- Ability to work shift rotation as needed or required – including possible nights, days, middays, weekends, holidays, etc.
- Ability to work mandatory overtime - as needed and/or required.

#### **2. Licensing, Certifications and Other Requirements:**

- Must become certified by the State of Utah as a Corrections Deputy.
- Must complete at least 40 hours of annual job related training.
- Must possess and maintain valid Utah Driver's License.
- Must maintain compliance of Iron County vehicle policies – including maintaining an acceptable driving record.
- Must be able to pass a pre-employment drug screen.

- Must successfully pass a background investigation, which may include criminal history records, education verification, credit and financial information, employment history, and personal reference checks.

**3. Physical Demands:**

- Typically sit at a desk or table.
- Regularly walk, stand, stoop, climb stairs, kneel, reach, push, pull, or twist.
- Occasionally lift, carry, push, pull or otherwise move objects weighing up to 100 pounds.
- Ascend or descend ladders, scaffolding, ramp, poles, etc.
- Use tools or equipment requiring a high degree of dexterity.
- Walk, stand, crouch or run on narrow slippery or erratically moving surfaces.
- Work for sustained periods of time maintaining concentrated attention to detail.
- Manage physically aggressive inmates as necessary.
- Distinguish between shades of color and communicate via radio.
- Work indoor and outdoor conditions in both light and dark environments.
- Outdoor work may include walking and/or running in hot weather, rain, snow, ice or other slippery conditions.
- Must possess a sense of touch, finger dexterity, gripping with fingers and hands, and hear voice conversations.
- Ability to hear alarms, use close vision, far vision, side vision, depth perception, night vision and color vision.

**4. Work Environment:**

- Must be able to work in confined spaces for extended periods of time.
- Work includes both indoor and outdoor conditions in both light and dark environments.
- This position may expose employee to smoke, noxious odors, fumes, and chemicals.
- This position, at times, may require wearing a respirator, safety glasses or goggles, ear plugs or muffs, rubber gloves, rubber boots, chemical resistant clothing, or other safety-related/personal protective equipment.
- Work exposes incumbent to unknown, dangerous, and/or life-threatening conditions.
- Work exposes incumbent to risk of injury, assault and possible injury from prisoners and/or the public.
- Work is often performed in noisy and high stress level areas or environments.
