If you would like to pay by credit/debit card (**Visa or MasterCard ONLY**), please fill in your information below (a \$3.00 merchant fee will be assessed to all fines paid by credit/debit card).

**CHECK ONE OF THE FOLLOWING:**

"ARRAIGNMENT" includes the formal reading of the complaint and the explanation of the rights of the defendant as a person accused of a crime and a formal entering of a plea. **It does NOT include trial of the case to decide innocence or guilt.** It is necessary that the bail be posted to forestall prosecution on the charge of "Failure to Appear".

**REQUIREMENTS FOR A PLEA IN ABEYANCE:** Traffic school only applies to traffic citations. It is **NOT** in lieu of either points against your record, fine for the citation **OR** traffic school fees. Traffic school is only available for moving violations, including speeding 1-25 MPH over the posted speed limit. **If you are charged with 26 MPH or more over the posted limit, a Class B misdemeanor moving violation or if you possess a CDL/Commercial Driver's License, you are NOT ELIGIBLE for traffic school.** All fees made payable to the Iron County Justice Court, not including the \$39.99 Online Course Fee.

**\*TOTAL fees for Online Traffic School are as follows:**

**The Plea in Abeyance consists of ALL the steps below:**

1. Pay court fines and fees for plea in abeyance/traffic school to the Iron County Justice Court. Make Money order or cashier's check payable to: IRON COUNTY JUSTICE COURT at 82 N. 100 E., Suite #101, Cedar City, UT 84720. Or you may pay by credit/debit card at (435)865-5335, from 9:00 A.M. until 4:00 P.M., Mon.-Fri., MST. **\*\*YOU MUST INDICATE THAT YOU INTEND TO TAKE THE TRAFFIC SCHOOL AT THE TIME OF PAYMENT!** If you fail to notify the Justice Court at the time of payment that you are going to attend the online traffic school, the violation will be reported to the Driver's License division as a conviction.
2. To register for the online traffic school, go to [www.ironcounty.net](http://www.ironcounty.net), go to Department, then Justice Court, and click on the traffic school link. (\*You must successfully complete the online traffic school WITHIN (30) DAYS OF THE DATE ON YOUR CITATION.) Once you complete the course, you will be mailed an official certificate from the website, GoToTrafficSchool.com within 7-10 days. You will need to fax, hand deliver or mail your certificate to the Iron County Justice Court (information listed below) in order to complete your plea in abeyance.
3. Abide by any other requirements included in the Plea in Abeyance. After completing Traffic School and paying all fines and fees, your citation will be dismissed (after a 90-day probation period).

The Iron County Justice Court **WILL NOT** send anything to you or receive any information stating that you have registered or completed the course.
